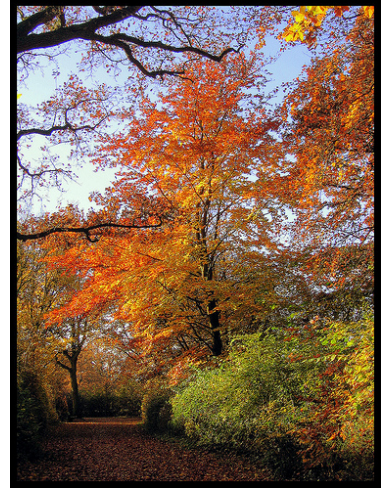



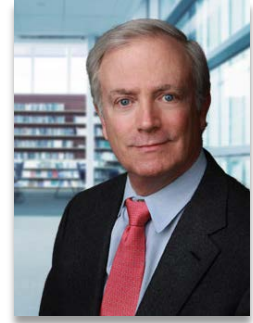

# BIOGRAPHIES



**Keynote Address: Thomas F. Schlafly, Partner,**  
*Thompson Coburn LLP*

Tom Schlafly has practiced in a number of areas since 1977. Since 1989, he has been President of the Saint Louis Brewery, Inc., which brews Schlafly Beer and is now the largest American-owned brewery in St. Louis. He serves on the Boards of Directors of the Legg Mason Partners Equity Funds and of Citizens National Bank of Greater St. Louis. He is the past Chairman of the Small Business Administration Regulatory Fairness Board for Region VII, which includes Missouri, Kansas, Iowa and Nebraska.

Schlafly is currently a member of the Board of Directors of the St. Louis Public Library, having been appointed and re-appointed by four different Mayors of the City, starting in 1984. He is also a Trustee of the St. Louis Art Museum and a member of the Board of Directors of the Greater St. Louis Area Council of the Boy Scouts of America. He has served on the Board of Directors of the Downtown St. Louis Partnership and the Georgetown University Board of Regents.

Tom Schlafly is a regular commentator on St. Louis Public Radio. He is also a chief lyricist for The Courthouse Steps, a troupe of singing lawyers who perform political parodies. He is also co-founder of the Saint Louis Brewery, the first microbrewery in Missouri, which produces the Schlafly line of beers.

As AALL Board Member Board Liaison to the AALLNET Committee and the Economic Status of Law Librarians Committee; Member of the Executive Board Finance and Budget Committee and the Executive Board Strategic Directions Committee.

Librarian-Lawyer-Knowledge Management-Competitive Analysis-Computer Programmer.... Greg's taken the Renaissance Man approach to working in the legal industry. In the spring of 2012, each interested faculty member at the IU Robert H. McKinney School of Law received an iPad. To help the faculty make full and effective use of these iPads, the Ruth Lilly Law librarians developed and implemented an education program about apps that we delivered electronically to faculty on a weekly basis over the summer of 2012. The emphasis was on apps that helped faculty with research, organization, and communication. In this session, learn how to develop a similar program that builds librarian-faculty partnerships.

***A-2: "Bad Human Communication Leaves Us Less Room to Grow:" Professional Growth Through Improved Communication.***

***B-2: Taking Slavery to Court: Black and White Struggles over Freedom in Antebellum St. Louis***

In 1857, a fractured US Supreme Court issued its infamous Dred Scott Case, a major victory for pro-slavery forces. It proved a major step toward civil war. Dred Scott, however, was not alone. Over 300 of his fellow St. Louisans sued for their freedom as well. Until the year 2000 most of these suits were previously unknown to history. These cases now constitute the largest single collection of freedom suits in the United States. The depositions they contain provide a unique oral history of a disposed people, as well as insight into the passion of those who wished to keep them slaves.

### ***D-1: Collecting and Circulating Study Aids: What's Right for Your Library?***

Does your collection include study aids? Which ones? Do you buy multiple copies? Where are they housed? How long do they circulate? This presentation will address these and more questions. This unique program will be a fun 60 minutes of questions and answers. Attendees will pick up a question to ask the speaker as they enter the room. The questions are gleaned from the results of a MAALL survey that asked Reference Librarians what they most want to learn about getting quick, accurate access to resources as cataloged in their libraries. The presenter's answers will look at reference services from a perspective of cataloging: past, present and the future.

Audience participation will be encouraged throughout the entire program. We will cover cataloging practices, MARC records, shared cataloging, problems with information delivery in our OPACs, reasons for getting baffling search results, tips for getting better search results, and the impact of RDA on Reference Librarians.

In this scenario based program the presenters will provide examples of initiatives, models and ideas that on paper looked great, but failed when implementation was attempted. The presenters will then facilitate a discussion with the audience about each scenario. The aim for the discussion will be to establish, should the initiative have failed, where the implementation problem began, if the problem is fixable and if you found a way to make it work how it could add value to your library.

Cloud technologies, i.e. SlideRocket, Dropbox and Prezi as well as immersive environments such as Xtranormal are increasingly being used for education and training. The goal of the presentation will be to inform professional librarians about the use of ubiquitous software for dynamic instruction and collaboration as an alternative or enhancement to PowerPoint.

This program will show how to use social media sites, business and work history, bankruptcies, neighbors, relatives and associates, charitable and political donations, attorneys, judges, experts and online obituaries to find phone numbers and addresses of missing people.

**H-1: Electronic Discovery: An Overview for Law Librarians.**

- **Speakers:** Randy Diamond, Director of Law Library and Technology Resources at the University of Missouri School of Law

Randy has taught a two-credit e-discovery at his school since 2010. This session will provide an overview of e-discovery law and technology issues covered in the course and their impact on law practice. Librarians are uniquely situated to contribute to the development and understanding of e-discovery best practices through their information management training and skills. Successful identification, preservation, collection, and production of electronic evidence requires advanced search techniques that are the subject of major recent e-discovery case law. This session will be of interest to academic law librarians looking to support or add to skills training in their law schools and to firm and court librarians who provide e-discovery research support to lawyers and judges.

## **DIRECTIONS FROM DRURY PLAZA TO SLU LAW SCHOOL**

*2 South 4th St, St. Louis, MO 63102 to 3700 Lindell Blvd, St. Louis, MO 63108*

1. Market is the street on the N side of the Drury Plaza.
2. Take Market W about 1.4 miles to Jefferson;
3. Turn R (north) and continue on Jefferson .2 miles to Olive.
4. Turn L (west) on Olive and continue on Olive 1 mile to Grand. (you will note the large white stone church on the left corner opposite you);
5. Turn L (south) on Grand and continue to Laclede (the 2nd stop light);
6. Turn R (west) on Laclede. The university's parking garage will be on your left. Enter at the first entrance. You may need to take a ticket at the gate. Visitor parking is clearly marked to your left. You may park anywhere in that area.
7. Depending on staffing at the exit gate, there may be a \$6 charge when you leave. Often weekend parking is gratis.
8. There is metered street parking closer to the Law School, the rate is \$1/hr., and the city's employees are quite vigilant.

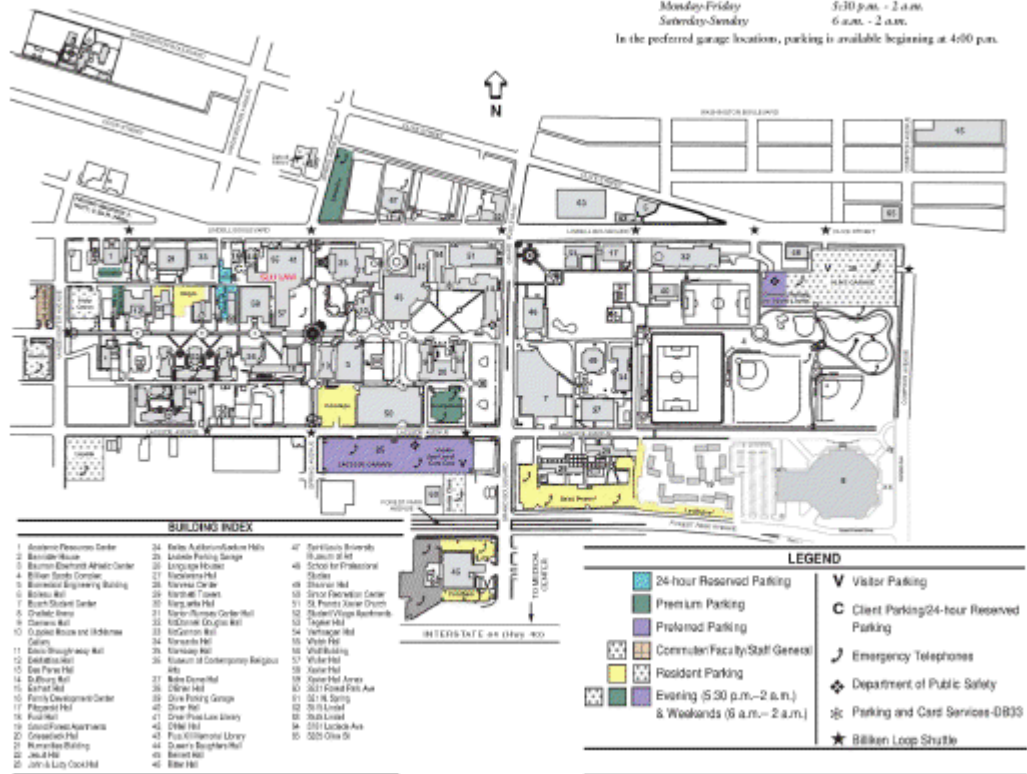
### **FROM THE LACLEDE GARAGE TO THE LAW SCHOOL**

9. On foot, exit the Laclede Garage onto Laclede Ave. and turn L (west);
10. Follow Laclede W to the next street (Spring Ave.) and cross Laclede. You will be standing looking N in front of a large gateway to a pedestrian mall with a clock tower and fountain in view at the end.
11. Go N and around the clock tower; continuing a half-block with the clock tower to your back. The Law School entrance will be on your left.
