Randy Diamond, MU School of Law, Trish Cervenka, Saint Louis University School of Law, and Jeff Sewell, Shook, Hardy & Bacon LLP, are teaching Legal Bibliography and Reference for the MU School of Information Science & Learning Technologies in winter semester 2002. The course is offered through MU Direct using Blackboard course software and ERES (the Electronic Reserve System at MU). A total of twenty-seven students are enrolled in sections in Columbia, Kansas City and St. Louis. The class includes both MLS students and practicing librarians who are taking the course for continuing education. Students have access to Lexis and Westlaw. The course meets in four Saturday face-toface sessions and online for weekly assignments and discussion forums.



## Access for the Hearing and Speech Impaired

"Maryland State Law Library Heightens Access to Its Services for the Deaf, Hearing and Speech Disabled," <u>LLAM News</u>, vol. 20. no. 1-2, Sept./Dec. 2001, p. 5. The Chief Justice of the Maryland state courts has been a proponent of providing access to the state courts for the disabled. Part of this effort has resulted in better access to legal information by the hearing and speeched impaired. The state law library now has special equipment for outside callers and for people in the library that allows them to communicate more effectively with the library staff.

Lawless, Helen, "The Incredible Shrinking Law Library?" <u>LLAGNY Law Lines</u>, vol. 25, no. 2, Dec. 2001. This author points out the various challenges in moving from print to electronic only sources. These challenges include having staff, patrons, support personnel (like information technology staff) involved in the decision making, in the training and sharing of information.
