

#### Iowa

#### Drake University

A dedication ceremony was held on September 19th to commemorate the opening of the Neal Smith Congressional Archives room in Drake's Dwight D. Opperman Hall and Law Library. For legal statistical data, go to <a href="http://www.abanet.org/marketresearch/resource.html">http://www.abanet.org/marketresearch/resource.html</a> to access the ABA's Market Research Department. Here you will find data showing the number of lawyers per state, court and caseload statistics, and rankings of law firms by size and revenue.

The SLA Tax Roundtable presented, *These Taxing Times: Taking Back our Roles,* featuring Susan Klopper, the Manager of Research Services for Goizueta Business Library at Emory University. Along with comprehensive and informative handouts, Ms. Klopper offered helpful tips about tax research including:

Most 1986 - present tax information is available electronically, but print resources are required for earlier materials.

The University of Mississippi now has the AICPA library collection.

Becoming a member of the SLA Tax Librarians Listserv is a lifesaver.

An efficient way to locate tax research pathfinders on Google is to do an advanced search for "tax research" in .PDF format in edu sites or domains.

Barbara Szalkowski, HALL Newsletter Editor, informs her readers that their newsletter is one of the few published in print these days, but that proposals are being discussed to change over to electronic format. A change in format may be in store for 2004 and the issue will be discussed this fall by the HALL Board. HALL Newsletter, Vol. 20 no. 4, July/August 2003.

#### LLAGNY

LLAGNY's Law Lines Newsletter reports that the Law Library Association of Greater New York is 65 years old as of November 17, 2003. In her President's Column, LLAGNY President Alma De Jesus dubs 2003 as the "year of the volunteer," and cites a cooperative effort between LLAGNY and SLA to present "Loss and Recovery: Librarians Bear Witness to September 11, 2001," an ALA-produced documentary which chronicled the personal stories of librarians who were very simply doing their jobs on that tragic day. Further activities for the year included a Basic Legal Research seminar presented by Ralph Monaco, Director of Library Services at New York County Lawyers' Association; a program entitled "Notary Law: How to Become a Notary," delivered by Nathan Rosen, V.P. of Credit Suisse First Boston; a Fordham University Law School presentation entitled "International and Foreign Law Series: Introduction to European Union Research."; and the LLAGNY annual research program for law students planning to be summer associates entitled, "Bridge the Gap."

James G. Murphy wrote "Practical Tips for End User Training," consisting of a concise one page article on how to train adult users learning new programs on computers. His suggestions include making the material more relevant to the students, soliciting volunteers from the class, team teaching and encouraging cooperation between the students to facilitate learning from one another. This is the second installment of a series of articles on end user training.

Finally, LLAGNY published a memorial to the late **Lukwik A. Teclaff**, Professor Emeritus and former Director of the Law Library at Fordham University School of Law who died on May 29, 2003 after a long illness. **Janet Tracy**, Professor of Research and Library Services at Fordham, wrote the moving tribute which chronicled the career of Professor Teclaff and recounted his many accomplishments. <u>LLAGNY Law Lines</u>, Vol. 26, no. 4, Summer 2003.
