## **Member News**

#### **Illinois**

Diane Murley, Reference/Web Services Librarian at Southern Illinois University School of Law Library, is the author of "What's the Matter with Kids Today?", 13 *Perspectives: Teaching Legal Research and Writing* 121-124 (2005). This article offers ideas for using law student experiences with Internet research to help them learn the research skills that will be expected of them when they are lawyers.

UND-Thormodsgard Law Library reports: Thormodsgard Law Library is part of the Online Dakota Information Network (ODIN) and the migration to ExLibris Aleph library system software is complete. The North Dakota Supreme Court Library is also an ODIN library. The interlibrary loan feature is in place and library staff across the state are becoming familiar with it and learning how to use it, as well as the Course Reserves feature. In our library here at UND we are working on loading or fixing serial patterns and working with budgets in the acquisitions portion of the software. The library system formerly used was MSUS PALS-TAC which was also used by the South Dakota Library Network and many libraries in Minnesota. All three states have adopted the Aleph Library System
