Topeka Program Promises Diversity

MAALL's fall meeting from October 19-21 in Topeka will offer attendees a wide range of educational programs. The program sessions begin on Thursday afternoon with Time Management by Wes Cochran, the author of "Time Management Handbook for Librarians." Following that program is a presentation on Brown v. Board of Education by the original plaintiffs, Linda Brown Thompson, and her sister, Cheryl Brown Henderson.

Friday's programs will be held on the Washburn University campus so that members will have ready access to computers for Internet sessions. During the initial morning session, participants can choose from the following concurrent programs: Collection Analysis and Technology--Preservation and Weeding in Today's Electronic Library; Government Documents Update--Finding Essential Resources; Technical Services Forum--Critical Issues; and The Internet's Top Ten Research Tools. The selections later that morning include: Collection Analysis and Development--Strategies and Media Selection for the Future; Regional Resources--Accessing State and Local Documents and Records; Reference Forum; and Internet Basics.

Planned for Friday afternoon are sessions entitled: Citation Update--Electronic Formats for the Future; Targeting Patron Needs--Guides, Pathfinders and Services; and Technical Services Applications on the Internet. Saturday morning will begin with a program on Doing More with Less--Controlling Costs to Permit New Growth. The final program of the meeting is Computer and Technology Demands--A Librarian's Survival Guide.

Complimenting the programs are a wealth of events planned by the Local Arrangements Committee under the direction of John Christensen, discussed elsewhere in this issue. Although the meeting officially begins with the opening luncheon on Thursday, members interested in learning about grant sources for law libraries can attend a pre-convention workshop at Topeka Public Library on Thursday morning. A weekend course in Law Librarianship offered through Emporia State's Graduate School of Library and Information Management also is planned (and is described on page 8.)

More details on the program will be provided during the MAALL luncheon at AALL and will be included with the registration mailing following AALL. Any questions or suggestions concerning the program can be directed to John Edwards, Program Chair, at Drake (je0371r@acad.drake.edu or 515-271-2141).

Local Arrangements Update - MAALL '95 in Topeka

Preparations are in progress to make your stay in Topeka enjoyable as well as professionally profitable as you participate in the annual meeting of the Mid-America Association of Law Libraries.

The Ramada Inn Downtown will serve as headquarters. For planning purposes, allot about \$50 per night for a room. Registration packets will be sent in late August.

A pre-meeting workshop on Grant Seeking will be conducted at Topeka Public Library from 10-11:30 a.m. TPL is a repository of Foundation Center materials. The presentation by Jim Rhodes should be of particular interest to law librarians in academic and governmental settings.

As is our custom, food will be first with the opening luncheon. Special presenters in the afternoon will include Linda Brown (plaintiff in Brown v. Board of Education) and her sister, Cheryl Brown Henderson. A reception at the Kansas Judicial Center early Thursday evening will provide an opportunity to build and renew friendships. Dinner will be "on your own." The local arrangements committee is preparing a guide to local restaurants to assist in your selection. A hospitality room at the hotel will be in operation each evening of the meeting.

Tours of selected libraries and facilities in Topeka will be available. The American Bindery, the Menninger Foundation, the new Kansas Center for Historical Research, and the Kansas Dept. of Education's interactive video classroom may be of interest. A school bus tour of Brown v. Board of Education historic sites in Topeka has also been arranged.

On Friday, breakfast and all programs will be conducted at Washburn University. Morning sessions will be conducted at the Memorial Union with Internet workshops in adjacent buildings. In mid-afternoon we will walk to the law school for programs and to view the Brown v. Board of Education exhibit in the law library. Some may wish to inspect the law school library which had a major addition completed in 1992. On the way back to the Ramada Inn the buses will visit the Brown v. Board historic sites if people are interested.

Friday evening will include dinner at the Top of the Tower. A panoramic view of the city and fine food

will establish the ambience for the major special event of the conference which will begin at 8 pm. The Moscow Kremlin Museums' Treasures of the Czars exhibit takes about 2 hours to view. The exhibition is currently in St. Petersburg, Florida. For an Internet preview, point your web browser at <http://www.times.st-pete.fl.us/>. In August the exhibit opens in Topeka (August 2-December 31), its only other U.S. showing.

The Treasures of the Czars exhibition contains approximately 265 works of art depicting historical, social, religious and artistic aspects of the lives of the Czars and Czarinas of the Romanov dynasty that ruled Russia from 1613 to 1917. The exhibition is one of the largest and most prestigious collections of the royal family treasures ever to leave the Kremlin Museums. Exhibit objects will be displayed in multiple galleries depicting two major periods of Russian history and culture: the seventeenth century pre-Petrine era of eastern orientation and the eighteenth, nineteenth and early twentieth century Petrine and post-Petrine eras of western orientation.

The Hospitality Room will be available after dinner and after the exhibition.

Saturday morning's sessions will be held at the hotel, beginning with a continental breakfast. As described in another article, MAALL will be conducting a graduate library school special topics course Friday evening through Sunday morning. We may have library school students and other newcomers attend some of our sessions and meal functions. Please join with the local arrangements committee in helping all to feel welcome.

Former Tonight Show band leader Doc Severinsen and a small band will be performing at the Topeka Arts Center on Saturday evening, October 21 at 8 p.m. Tickets go on sale in mid-September and range from \$22.50 to \$27.50 plus tax. Ticket orders 800-949-8722.

Travel Grants for 1995 MAALL Meeting

Deadline: August 1, 1995

The Mid-American Association of Law Libraries, Grants Committee, invites applications for travel grants to attend the 1995 MAALL Annual Meeting in Topeka, Kansas, October 19-21, 1995. The amount of each award is \$300.

Applicants must be MAALL members or paraprofessional staff members who wish to attend the Mid-America Law School Library Consortium Workshop. The Grants Committee will consider the following criteria in evaluating the applications:

1. Usefulness of the meeting to the applicant.
2. The applicant's past contributions to MAALL.
3. Proven or potential contributions to law librarianship.
4. Financial need.

Application forms for MAALL members and for paraprofessional staff members are inserted in this issue. Deadlines for both applications are August 1, 1995. Applicants will be notified of the Grants Committee decisions within three weeks following the deadline.

The MAALL Executive Board has established the following guidelines for travel grants awards:

1. The Executive Board annually determines the type, number, and amount of MAALL travel grants.
2. Applicants must be current members of MAALL or a designated member of an institutional membership at the time the application is made, or a paraprofessional staff member attending the Mid-America Law School Library Consortium Workshop.
3. The travel funds must be used for the designated meeting or workshop.
4. A grant recipient who cannot attend the designated meeting must return the award to the Grants Committee. Grants are not transferable.
5. A member may not receive a grant two years in succession.
6. The Marian Gallagher Grant is award to the applicant who is newest to law librarianship.
7. The MAALL Grants Committee selects the travel grant recipients. The members of this year's committee are Cheryl Nyberg, Chair; Susan Goldner; and Caitlin Robinson.

MAALL to Offer Course Through Emporia State's Graduate School of Library and Information Management

Why volunteer? Maybe you've always wanted to teach library science students, or maybe you're looking for something to add to your resume.

At the MAALL town meeting in Little Rock in October 1993 the suggestion was made for MAALL to offer an introductory course in law librarianship as part of the annual meeting. As a follow-up to that idea, Emporia State University's School of Library and Information Management was contacted and agreed to sponsor such a course. It will be offered in conjunction with the annual meeting in Topeka in October, for a credit of one hour.

The course will involve 15 contact hours and will run from Friday evening, October 20 to Sunday, October 22. MAALL will be paid \$900, which will help offset Annual Meeting costs. The volunteer

instructors will be drawn from MAALL membership. The purpose of this brief article is to solicit volunteers to teach one or more of the following sessions. If you are interested in teaching an assigned topic, or teaching a particular session, or have suggestions for a different topic that should be offered, please contact John Christensen, who will be coordinating the course with ESU's library school. MISSOURI

Missouri Library Network Corporation

MLNC, with the assistance of the Missouri State Library, will organize a two-month trial of OCLC's FirstSearch service for September-October 1995. The trial will have four goals: (1) to allow libraries to evaluate FirstSearch in "real" environment; (2) to build support for a possible group purchase within Missouri; (3) to identify the number of simultaneous sessions necessary to support the group's reference needs; (4) to identify the databases most heavily used by trial participants.

Libraries must have Internet access with telnet capability to participate in the trial. Information and sign-up forms will be sent to Missouri libraries in early June. Orientation sessions will be held in August.

U.S. Court of Appeals, 8th Circuit Library

The U.S. Court of Appeals, 8th Circuit Library, St. Louis, has filled its two vacant positions. Terry Ellen Ferl will begin work in June as Technical Services librarian. Terry has an M.L.S. from the University of California at Berkeley. Since 1979, she has been assistant head of the Bibliographic Records Section at the University of California, Santa Cruz. In recent months, she has worked on a special rare books cataloging project for St. Louis Public Library. Terry is co-author of two cataloging books in the Neal-Schuman "How-to" series.

Joan Stevens has been promoted to the position of Reference/Cataloging Librarian. Joan has been a Library Technician for the 8th Circuit Library since 1989. She holds a B.A. from Southwest Missouri State University and expects to complete her M.L.S. from the University of Missouri--Columbia this summer.

In late April, the library moved into Phase I of a new stacks area. Phase II will probably be completed by the end of May. The completed project will increase the library's shelving capacity by

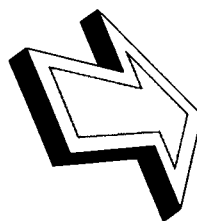
