

# Minutes of the Mid-America Association of Law Libraries Business Meeting

Friday October 9, 1998, 11:30am - 1:00pm, Milwaukee Hilton - Empire Ballroom

#### **Opening Announcements:**

James Duggan opened the meeting with the new gavel at 12:15 pm. He recognized special guests Marian Parker of Matthew Bender, our host for the luncheon, and Margie Axtmann, Vice-President/President-Elect of the American Association of Law Libraries.

#### Approval of Minutes from the Anaheim Meeting:

Minutes of the association meeting in July, 1998 were approved as published.

#### Treasurer's Report:

Janet McKinney reported that the treasury was in balance. She also reported there are 229 members.

#### **Committee Reports:**

Midwest Regional Arrangements (Milwaukee)

President James Duggan said, "We're here!"

Program 1998 (Milwaukee)

President-Elect Jung reported that of 14 programs at this regional meeting, 6 were contributed by MAALL. She thanked committee members Mary Ann Nelson, Patti Monk, and Susan Morrison.

Grants

There were three grant recipients and six applications. Recipients were Marie Mack, Washburn; John Sevens, U.S. Courts in St. Louis; and Eric Cooper, University of Illinois. A change in grant criteria to clarify how often grant recipients may receive grants was recommended. James said the executive board was studying this issue.

Janet McKinney reported on 1999 Kansas City local arrangements. She said we would be staying at the Wyndham Garden Hotel with a \$99 room rate. The meeting is scheduled for October 14-16. Possible visits are the Federal Building, Arabian Steam Boat Museum, jazz district, and Baseball Museum.

#### **New Business:**

The possibilities of Fayetteville and St Louis were on the table for the site of the 2000 MAALL meeting. Mary Kay Jung withdrew St. Louis. Glen Ahlers presented information and said the dates were October 8-10 and the convention hotel would be the Hilton Downtown. Houdek moved to accept by acclamation.

Nominating Committee & Election Chair, John Edwards stated the nominees were listed in *MAALL Markings*. Glen-Peter Ahlers is the nominee for Vice President/President-elect and Crata Castleberry is the nominee for Secretary. Both were accepted by acclamation.
